### CLASS SPECIFICATIONS

Hopeful Hunter, Schooling Hunter, Low Hunter and Hunter Warm-Ups are open to all horses, ponies and riders.

Short Stirrup, Pony Hunter, Children's Hunter, Adult Amateur Hunter, Junior/Amateur-Owner Hunter, Pre-Children Adult Hunter, Age Group Equitation's and NCHJA Equitation Medals are run in accordance with NCHJA rules.

Open Hunter and Mini Classic – Entry fee: \$25.00. Prize money for first 4 places \$50/\$25/\$15/\$10. Minimum of 8 riders. Second hunter round of division is the first round score of Classic. Class must be entered before start of division. Second round of the Classic can be ridden with the division or with the Classic class. Prizes will be awarded at the end of the day.

Beginner Rider: Riders in their first year of showing. Judged on position and control. Courses may be trotted.

Young Entry: Junior riders in their 1st or 2nd year of showing. Fence height 18". Simple changes allowed.

Novice Rider: Open to riders of any age. Courses will include diagonal lines. Simple changes allowed.

Long Stirrup: Open to riders over 12 years of age in their first 2 years of showing.

### General Information

1. Recognized divisions count toward year-end NCHJA awards.
2. Six ribbons will be awarded in all classes.
3. Championship and Reserve ribbons will be awarded in each division.
4. Classes will be judged on soundness, pace, manners, way of going & jumping style. Emphasis on suitability will apply.
5. Everyone must wear Approved Protective Head Gear when mounted.
6. Returned Checks will be assessed \$30 plus collection fees.
7. Minor Exhibitors: Parents or guardians of minor exhibitors shall not hold the Show Management and/or the Facility and its owners liable for any injury to such minor. No minor's entry will be accepted unless it is signed by a parent or guardian or agent.
8. Limited stabling is available; \$30 per day or night.
9. All exhibitors will be charged \$15.00 per horse to cover office fees and medical services.
10. All horses on the show grounds must be registered at the show office.
11. Negative coggins required for all horses.
12. All dogs must be kept on leashes.
13. Concessions will be available on the show grounds.
14. Schooling will be allowed until 8:20 am in both rings and at the schooling break as time allows.
15. Formal attire is not required in the covered ring for unrecognized classes.

### Condition of Entry

Participants realize and accept the inherent risks of equine activities. Every horse entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its Directors and Employees, the Management and the Facility harmless for any loss or accident to his horse, horses, or equipment which may occur from sickness, fire or otherwise. All riders are required to sign a release waiver before riding.

**Management** reserves the right to interpret all questions and conditions in regard to or arising out of an incident at the show without claims for damages or recourse of any kind. All questions, not covered in these rules and regulations shall be decided by Management, and their decision is final. Management reserves to itself the right to refuse, accept conditionally, or cancel entries; disqualify riders or exhibitors; prohibit exhibition or entries; cancel or combine classes, or to reschedule classes, and/or to change rings or rotate judges.

**Measurement,** ponies must present USEF card or be measured before showing.

**Order.** Management may designate a posted order of go, use THE ONE MINUTE RULE, use a "dotted line" and/or change the ring schedule

**Discourtesy** to an official by any owner, rider, trainer, or groom will disqualify horses with which they are associated and fees are forfeited.

Horse Show Participant (or Parent/Guardian of Participant if a minor) is aware of the many obvious and non-obvious risks associated with a horse show and does hereby ***release and hold harmless MacNair's Country Acres, Inc. and its affiliates, including its shareholders, agents, employees, officers, directors, representatives, assigns, affiliated organizations (whether nonprofit or for profit), boarders, students, lessors, lessees, insurers and others acting on behalf of any of them (collectively, "MacNair's") from all claims, demands, causes of action and legal liability related to the Horse Show Participant's participation in or presence during the Horse Show, whether the same be known or unknown, anticipated or unanticipated, foreseeable or unforeseeable, and even if such are the result of the negligence and/or acts or omissions of MacNair's or other Horse Show Participants or other individuals present on the Farm during the Horse Show.***

Horse Show Participant (or Parent/Guardian of Participant if a minor) further agrees to (a) waive all claims which may otherwise arise from an injury to a Horse Show Participant or other individual associated with Horse Show Participant while using or being present at the Farm; and (b) not pursue any claims, demands or causes of action against MacNair's for any economic or non-economic losses arising out of the Horse Show which are the result of any bodily injury, death or property damage suffered by a Horse Show Participant or any other individuals present on the Farm. Further, Horse Show Participant (or Parent/Guardian if Participant a minor) agrees (i) to be responsible for any and all damages, injuries and/or loss of life in connection with the Horse Show which are caused by Horse Show Participant or any other individual associated with Horse Show Participant who is present on the Farm; and (ii) to indemnify MacNair's from any losses or expenses, including but not limited to attorneys' fees, which MacNair's incurs in connection with any such damages, injuries and/or loss of life.
