- 2. Six ribbons will be awarded in all classes. Championship and Reserve ribbons will be awarded in each division.
- 3. Classes will be judged on soundness, pace, manners, way of going & jumping style. Emphasis on suitability will apply.
- 4. Division descriptions, association rules & membership forms can be found online for NCEHA (<u>www.nceha.com</u>) & NCHJA (<u>www.nchja.com</u>). Online show programs & entry forms can be found on both of these websites if additional copies are needed.
- 5. All membership fees are to be paid separately and may be left with the show secretary (by noon on Sunday) attached to completed association application with check, copy of coggins report, & copy of pony measurement card. Membership forms will be available in the office. Membership is required for accumulation of points. Not necessary to show.
- 6. Everyone must wear Approved Protective Head Gear when mounted.
- 7. Minor Exhibitors: Parents or guardians of minor exhibitors shall not hold the Show Management and/or the Facility and its owners liable for any injury to such minor. No minor's entry will be accepted unless it is signed by a parent, guardian or agent.

- 11. Refunds With Vet or Doctor letter a full refund will be given if received prior to 9:00 AM Wednesday 3/18/15. Partial refunds given with judge or stewards notification for unsoundness. Class changes should be made prior to 5 pm Friday, March 20, 2015 without penalty for pre-entries.
- 12. Returned Checks will be assessed \$50 plus any additional collection fees if charged by financial institutes.
- 13. Check In All equine on the show grounds must be registered with Show Secretary Showing/Schooling/Visiting. Please stop by the show office to check in & pick up exhibitor numbers. Tack stall splits should be filed by noon Saturday or trainer will be billed full fee.
- 14. Negative coggins required for all horses. Please place copy on stall door or trailer door (if coming in for day showing w/o stall).
- 15. Schooling will be available Friday noon until 10:00 pm. Arenas will open at 5:30 AM Sat & Sun and close at 7:15 AM Indoor Arena and 7:45 AM in Covered Arena. Arenas should be open after the show ends on Sat until 9:00 pm check with the office by 6 pm if you have needs.
- 16. Concessions will be available on the show grounds.
- 17. Dogs and cats must be kept on leashes & attached to human companion. Ag Center staff may request proof of vaccinations.

<u>Walk Trot Division</u>: For the beginning rider in their first year of showing. There is no age limit, except the rider must be a junior. May not cross enter into any other division except Maiden YE. Three classes offered: EO, Pleasure, & Hunter.

Maiden Young Entry Division: Open for the beginning rider in their first years of showing. There is no age limit, except the rider must be a junior, who is not participating in any required division class. May enter added classes; but may NOT enter any other jumping class over 18" requiring a change of direction. They may enter a flat class. YE does not require formal attire, however paddock boots & a USEF approved helmet with harness are required. To be judged on 100% equitation. Division consists of two over fences classes & one flat class at the walk, trot, & canter. Fences must be no higher than 18" & may be cross rails, with riders jumping the four outside fences twice around (no change of direction). Ponies & horses are allowed.

Novice Young Entry Division: For the more experienced beginning rider. There is no age limit, except the rider must be a junior, who is not participating in any required division class, but may enter added classes. To be judged on 100% equitation. Two over fences classes (18") are allowed & may include changes of direction.

Short Stirrup Hunter Division: Open to riders 12 years of age or under (age as of Dec 1st of the previous year). Riders are not eligible to compete in this division for more than two years, regardless of age. Year is determined from the first date a rider competes in SS at an EHA show. SS EQ Classes are offered & points in those classes are kept as individual class points & are not combined with the SS division points. Jumps will be 2'0". To be judged on performance, way of going, manners, soundness & suitability as a SS mount.

Short Stirrup Equitation O/F & on the Flat: Open to riders 12 yrs of age or under. Jumps will be 2'0". To be judged on the rider.

Low Hunter Division: Open to any rider on a horse or pony. Jump course to be set at 2' and 2'3". To be judged as one complete class on performance, manners, way of going, suitability to the rider & soundness.

Long Stirrup Hunter Division: Open to any beginner rider in their first & second year of showing. Riders are not eligible to compete in this division for more than two years. Year is determined from the first date a rider competes in LS at an EHA show. May enter added classes. May ride in any flat class, according to division specifications & may cross into Low Hunter Division. Adults may ride ponies; Jr riders may not ride ponies in this division. Judged on performance, manners, way of going & soundness. Jumps 2'. LS Equitation classes not part of the division points. **Long Stirrup Equitation:** One O/F class & one Flat class offered. To be judged on the rider. Open only to Long Stirrup Riders.

Open Working Hunter Horse Division: Open to any rider on a horse. All horses to jump 3'0" or 3'3" with in/out distance 24' to 26'. Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

Jr Working Hunter Division: Open to juniors riding a horse & will be combined with Amateur Owner Hunter. Jump ht is 3'3" with in/out distance 24' to 26'. *Cannot cross enter Children's Hunter, Low Hunter, Pre-Children/Adult with same rider/horse combination.* Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

<u>Amateur Owner Working Hunter Division:</u> Open to amateur owners or an amateur member of the owner's family & will be combined with Jr. Working Hunter. Jump ht is 3'3" with in/out distance 24' to 26'. Leased horses are not eligible & multiple ownership is not permitted unless all owners are members of the

same family. *Cannot cross enter Adult Hunter, Low Hunter, Pre-Children/Adult with same rider/horse combination.* Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

Adult Amateur Working Hunter Division: Open to an adult amateur riding a horse or pony. NO PROFESSIONALS. Jump ht is 2'9" with in/out distance 24' to 26'. Can be combined with Children's Hunter if less than 3 entries. *Cannot cross enter Jr/Amateur Owner, Low Hunter, Pre-Children/Adult with same rider/horse combination*. Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

EHA Adult Equitation: Open to amateur senior members with only one rider per horse. Hts 2'9". May be combined with Children's EQ if less that 4 entries. To be shown over a hunter type course of not less than 8 fences. Judges may ask competitors to perform USEF tests 1-19.

Children's Hunter Division: Open to junior riding a horse. NO

PROFESSIONALS. Ht 2'9" with In/Out 24' to 26[°]. Can be combined with Adult Amateur Working Hunter if less than 3 entries. *Cannot cross enter Jr/Amateur Owner, Low Hunter, Pre-Children/Adult with same rider/horse combination.* Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

<u>Children's Equitation</u>: Open to junior members with only one rider per horse. Hts 2'9". May be combined with EHA Adult EQ if less than 4 entries. Contestants in the Children's EQ class are not eligible for the EHA Pony EQ class at the same show. To be shown over a hunter type course of not less than 8 fences. Judges may ask competitors to perform USEF tests 1-19.

Open Schooling Hunter: Open to any rider on a horse, (adults may ride ponies). Hts 2'9" and 2'6" with In/Out 24' to 26'. Hts will be judged together. Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

Pony Hunter Division: Open to any junior rider on small, medium or lg pony. No junior over 12 yrs may ride small pony section. No junior over 14 yrs may ride regular medium pony section. Riders under 18 yrs may ride for other exhibitors who have more than one entry U/S. Ponies must be handled by junior exhibitors in all phases of a class. (Small 2'/Medium 2'3"/Large 2'9") Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

Pre-Children's & Pre-Adult Amateur Hunter: Open to any junior or adult amateur rider on a horse or adult on a pony. NO PROFESSIONALS. Ht 2'6" with in/out 24' to 26' (optional). Riders may cross enter Low Hunter & Open Schooling Hunter. Judged on performance, manners, way of going, suitability to the rider and soundness. Course consists of 8 fences with change of directions.

Age Group Equitation: The fence heights for the age equitation shall be as follows:

- 1. 11 & under fences 2'0'' 2'3''
- 2. 12 through 14 fences 2'3'' 2'6''
- 3. 15 through 17 fences 2'9" 3'0"

Classes for 12-14 and 15-17 may be combined if there are less than 3 entries in either section. In equitation over fences classes, riders must compete at the correct fence height for their age.
