### Show Information:

1. Recognized divisions count toward year-end NCHJA awards.
2. Six ribbons will be awarded in all classes.
3. Championship and Reserve ribbons will be awarded in each division.
4. Classes will be judged on soundness, pace, manners, way of going & jumping style. Emphasis on suitability will apply.
5. Everyone must wear Approved Protective Head Gear when mounted.
6. Returned Checks will be assessed \$25 plus collection fees.
7. Minor Exhibitors: Parents or guardians of minor exhibitors shall not hold the Show Management and/or the Facility and its owners liable for any injury to such minor. No minor's entry will be accepted unless it is signed by a parent or guardian or agent.
8. Limited stabling is available; \$25 per day or night.
9. All exhibitors will be charged \$15.00 per horse to cover office fees and medical services.
10. All horses on the show grounds must be registered at the show office.
11. Negative coggins required for all horses.
12. All dogs must be kept on leashes.
13. Concessions will be available on the show grounds.
14. Schooling will be allowed until 7:20 am in ring 1 and 10:30 am in ring 2

### Condition of Entry

Participants realize and accept the inherent risks of equine activities. Every horse entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its Directors and Employees, the Management and the Facility harmless for any loss or accident to his horse, horses, or equipment which may occur from sickness, fire or otherwise. All riders are required to sign a release waiver before riding. **Management** reserves the right to interpret all questions and conditions in regard to or arising out of an incident at the show without claims for damages or recourse of any kind. All questions, not covered in these rules and regulations shall be decided by Management, and their decision is final. Management reserves to itself the right to refuse, accept conditionally, or cancel entries; disqualify riders or exhibitors; prohibit exhibition or entries; cancel or combine classes, or to reschedule classes, and/or to change rings or rotate judges. **Measurement**, ponies must present a valid USEF or NCHJA card or be measured before showing. **Order**. Management may designate a posted order of go, use THE ONE MINUTE RULE, use a "dotted line" and/or change the ring schedule **Discourtesy** to an official by any owner, rider, trainer, or groom will disqualify horses with which they are associated and forfeit any fees.
