2014 Biosecurity Protocols

The Gulf Coast Classic Company is dedicated to the health, welfare and safety of all exhibitors both equine and human. To protect our equine partners, we will be enforcing the following protocols at both the Pensacola, FL and Mississippi Gulf Coast Circuits this winter.

It is advised that all horses stabling on the Gulf Coast Winter Classic show grounds arrive between 7:00 a.m. and 6:00 p.m. If it is necessary to arrive at any other time you must check in with the night security officer.

- 1) A current negative Coggins test is required. It is strongly recommended that all horses be vaccinated for Equine EHV-1 (either modified live or killed vaccine) no sooner than 7 days prior and no later than 90 days prior to entering the show grounds. Most EHV-1 vaccines are only considered effective for 90 days. Check with your veterinarian about which vaccine you should use.
- 2) A Health Certificate must be signed by a licensed veterinarian within 15 days of arrival at the Gulf Coast Show Grounds, documenting that the horse has:
 - a. Received regular and consistent vaccination against Equine Influenza and EHV 1 & 4 with most recent booster being within 90 days and not within 7 days.
 - b. Not shown symptoms of or been treated for EHV-4/1 within the past 28 days.
 - c. Not been at a facility under quarantine for EHV-4/1 or exposed to any horses showing symptoms of EHV-4/1 within the past 28 days
- 3) Current vaccination against WNV, EEE, WEE, Tetanus and Rabies is strongly recommended.
- 4) You should be able to document your horse's normal temperature before arrival. Please do not ship horses with elevated temperatures. It is recommended that you establish a log of temperatures taken at least twice daily. If there is an elevated temperature for more than a 24 hour period, please consult your local veterinarian immediately.
- 5) Every effort should be made to minimize stress and commingling of horses shipped long distances. Extra hours on a horse van, or moving from stable to stable is the fastest way to compromise your horses and the health of your neighbors' horses.
- 6) Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to Gulf Coast Winter Classic Show Management and to the Show Veterinarian. It is always better to err on the side of safety. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.
- 7) Please take the time to review equine good hygiene practices. Please convey the importance of this to your equine caretakers for their daily routines.

Rules and Regulations

Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

The Horse Show Committee reserves the right to interpret all questions and conditions in regard to or arising out of, or incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management; its decision to be final.

The Horse Show Management reserves the right to limit entries in any class, section or division, to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without any claim for damages; to change any course, to add a dotted line, to cancel or combine any unfilled classes, or to reschedule classes, after due notice to exhibitors; to change rings or rotate judges; to change specifications in jumper classes as competition warrants. Every horse entered herein for competition will be under the control of the Horse Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show and the officials, employees, directors, officers, sponsoring entities of the horse show and the facilities at which the horse show is held blameless for any loss or accident to his horse(s), employee(s), or equipment which may occur from sickness, fire or other cause. Each horse entered for competition will be assessed a USEF Federation Fee of \$16 (\$8 Drug and Medication/\$8 USEF) and a \$2 USHJA fee.

Entries: The **closing date for entries** of the Pensacola Winter Classics is **Wednesday, December 18, 2013**. Entries received at the show will be charged a late fee of \$25. Entries received after we close our Johns Island Office on Monday, January 6, 2014 will receive a late fee of \$25. *After closing date stall fees are non-refundable.* Entries should be sent to the address shown on the entry blank. Checks should be made payable to Gulf Coast Classic Company. Numbers WILL NOT be issued without a SIGNED OPEN CHECK lodged with the Horse Show Secretary. The entry form for each show must include the following:

- Horse name and complete description;
- All classes or divisions entered;
- All mandatory signatures, including legal guardian in the case of a minor exhibiting;
- Organization membership numbers;
- Social Security or Federal ID number of owner.

Scratched Horses: Horses scratched from the show before the closing date will receive a full refund. Horses scratched before arriving but after the closing will be charged the stall fee unless that stall is sold. Horses scratched after arrival will be charged the stall fee, night watch fee, and the services fee.

Stabling: Horses may arrive on the showgrounds starting on Monday, January 6, 2014. Stalls, whether occupied by horse, feed or tack, will be available Monday, January 6, 2014. Initial bedding will not be provided. As stabling will be limited this year, the Monday - noon move in/move out stipulation will be strictly enforced. For any exceptions to the above, please call 843-768-5503.

Stalls: 10' x 10' with doors are \$225 per week.

Paddocks: Pensacola Winter Classic paddocks are limited to 40 on grass. \$225 per week. Those reserving 3 weeks have priority.

Night Watch: All horses occupying a stall, whether showing or not, will be required to pay a show night watch fee of \$15 per show. This service is not optional. Horses will be checked 6 times a night each night of that show week. Night Watch provided by Equine Nighttime Security.

Competition Office Hours

Competition Days: Office opens one hour before the start of the first class and closes 30 minutes following the last class.

Non-Competition Days:

Mondays 9:00 a.m. - 12:00 noon
Tuesdays 9:00 a.m. - 5:00 p.m.

Check Out: Any horse show bills not checked out at the conclusion of each show will be assessed a \$50 fee for check out. *Any mistakes at check out must be resolved within 24 hours.* Check your bills carefully.

Day Exhibitors: Horses entered but not stabled must use the designated area for day exhibitors. \$40 grounds fee.

Service Fee: All horses, showing or nonshowing, will be assessed a fee of \$50. This fee allows the horse UNLIMITED add/scratches from classes, access to schooling areas and rings at designated times and defers all charges for parking passes.

Splitting of Tack Stalls: The horse show office will be happy to split the tack stalls per the Trainers instructions among his/her customers up to each Friday at 11:00 AM. At that point, the total amount will be billed to the trainers barn account.

Schooling: Schooling in the show rings without permission is prohibited at all times. This includes riding, exercising and lunging. \$100 fine for anyone caught in the rings before or after the show without permission and they will be eliminated from competition.

Lunging: All lunging will be restricted to designated areas. Lunging will not be permitted in ANY ring areas at any time.

Feed & Bedding: In order to assure exhibitors of an adequate supply of feed, hay, and bedding based on fair market prices, no other feed vendor will be permitted on the grounds without the express permission of management. For same day delivery, feed orders must be received prior to 12:00 noon. For feed and bedding reservations prior to arrival, call 843-768-5503.

Farrier: No farrier other than the official competition farrier will be permitted to shoe on the grounds without express permission of the management. All Farriers must use the designated Farrier area.

Non-Negotiable Checks: Checks returned by the bank for any reason will be assessed a penalty of \$50 or 10% of the check amount, whichever is greater. Upon notification of a returned check, accounts will be given three (3) days to make full payment, including the penalty, which must be paid in certified funds, cashier's check or money order. Overnight mail service is advised in order to avoid notification of the sanctioning organizations for disciplinary action.

Poling and Off-Sets: Manual poling and use of bamboo off-sets are prohibited for all horses competing in the Pensacola Winter Classics. Any rider, trainer, groom, or any other person who is in violation of the rules set forth above will be fined \$500 for each incident and may be suspended from further competition for the duration of the scheduled competition starting from the time of the incident.

Any horse upon which a violation of the manual poling and/or use of bamboo off-sets rule is perpetrated will be suspended from competition for the duration of the scheduled competition. All entry fees for the classes entered during the suspended period of the horse in question will be forfeited.

Formal Attire:

Hunters: Scarlet, black or dark blue coat; white shirt with white stock, tie, or choker; white, buff, or canary breeches; huntcap, derby or hunting silk hat. Juniors must wear protective headgear in accordance with USEF rules. NO EXCEPTIONS.

Equitation: Black, dark blue, dark green, or dark gray coat; white shirt with white stock, tie or choker, white, beige or canary breeches. Juniors must wear protective headgear in accordance with USEF rules. NO EXCEPTIONS.

Motorized Vehicles/Golf Carts: Under Florida State Laws & USEF Rules unlicensed drivers are not permitted to operate any motorized vehicles - ATV'S, motorcycles, golf carts, etc., on the show grounds. Failure to abide by these regulations will subject the exhibitor to suspension from the horse show. For golf cart rental, Pensacola Winter Classics, call 800-714-2201 for reservations. Reference USEF GR 301. See Minor Exhibitors.

Motor Homes: At the Pensacola Winter Classics motor homes and camper sites **are available but limited. To ensure a camper space please complete the camper reservation form and return with payment (check or credit card) before arrival. \$250 weekly.** (Includes septic or one pump out per week.) A \$50 fee will be added if not prepaid by closing date.

Parking: Fire regulations prohibit all vehicles, including trailers, vans and passenger vehicles from being parked in the stable areas. Vans and trailers will be allowed in the stable area only to load or off-load. PARKING AREAS WILL BE DESIGNATED AND VIOLATORS WILL BE TOWED AWAY AT OWNER'S EXPENSE.

Protective Headgear: All exhibitors are required to wear properly fitting protective headgear when mounted on the show grounds. Additionally, all juniors must wear properly fitting protective headgear with the harness secured and properly fitted while riding in the designated schooling and exercise areas, the show ring and while jumping anywhere on the show grounds. All riders must wear ASTM/SEI approved helmets while jumping on competition grounds and in hunter, hunter seat equitation and jumper classes where jumping is required. It is the responsibility of the rider, the parent/guardian or trainer of the junior exhibitor to confirm headgear worn complies with appropriate safety standards, is properly fitted and in good condition. Reference USEF GR 318.

Minor Exhibitors: Parent(s) or guardian(s) of minor exhibitors shall hold the Horse Show Management and the Facility harmless for any injury to such minor. No child's entry will be accepted or number issued unless entry is signed by a parent or LEGAL guardian. The signature of unrelated persons WILL NOT be accepted.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Dogs: All dogs must be restrained at all times while on the show grounds. Dogs are the ultimate responsibility of their owner. The dog owner is responsible for keeping their dogs restrained at all times while on the show grounds.

Prize Money: Prize money will only be awarded to the recipient of record on the entry blank provided there is valid US Social Security number, Federal ID or Tax Identification Number and corresponding name and address. Prize money will be printed at the conclusion of the event. During multiple week events, prize money checks can be picked up in the Horse Show Office on Thursday. Prize money checks will be mailed within 30 days of the conclusion of the event. Please confirm information on entry form is correct to insure prompt and accurate delivery of prize money. **USEF GR:** 1210.6

Caveat: Due to uncertainty:

- classes with \$25,000 require 15 entries; less than 15 the classes may have \$10,000 in prize money with a \$300 entry fee;
- classes with \$10,000 require 15 entries; less than 15 the class may have \$5,000 in prize money with a \$250 entry fee;
- all Hunter Classics with prize money require 6 entries or the classes may be combined or cancelled;
- all Jumper Classes with prize money require 6 entries or the class may be combined or cancelled.
- JR/AO Jumpers require six entries in each high and low otherwise the class will run as a JR/AO High Low.

Electrical/Fire Regulations: All electrical installation and connections must meet all state and county codes. Aisles shall be maintained clear for a minimum of six (6) feet wide by eight (8) feet high. No obstructions or projections shall be allowed in these aisles. No Class I Flammable liquids such as gasoline, are allowed inside the buildings. Cooking is not permitted within any stable area. Anyone found in violation shall be subject to dismissal from further participation in the Horse Show without recourse.

Non-Showing Horses: All Non-showing horses must fill out an entry blank and be assigned a back number. All Non-showing horses will pay the Stall fee, the Service fee, and the Night Watch fee.

Ticketed Warm-Up: Tickets should be purchased in the horse show office and are good for one round of eight jumps. Tickets are non-refundable.

Liability: The Gulf Coast Classic Company, The Classic Company, Escambia Equestrian Center, their officials, and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectators, guest, rider, groom, attendant, other employees, animals, or equipment at any of the competitions. All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents, their horses, or their dogs. They are therefore strongly advised to take out third party insurance providing full coverage for participation in equestrian events, and to keep that policy up to date.

WARNING: UNDER FLORIDA LAW, AN EQUINE ACTIVITY OR EQUINE SPONSOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES PURSUANT TO THIS ACT.
